CANCELLATION: Full payment will be due & payable to ARHA if cancellation is received less than forty-five (45) days prior to the wedding date. This includes all monies for vendor services and F&B if ARHA has contracted for services.

All custom packages and weddings with two (2) or more events will be charged a twenty percent (20%) event planning fee in addition to the package costs. The 20% is based on total revenue of the event(s). Rates are valid through December 31, 2008 and are subject to change.
